Location: Wellborn Community Center at 1340 - 8th Avenue, West of CR 137, between 10A and the brick road.

Times: Friday 9:00 am 'til 9:00 pm - Saturday 7:00 am 'til 5:00 pm - Sunday Rain Date

Rules: Vendors will not be allowed to sell if a copy of Sales Tax Certificate is not submitted with application or turned in by May 5, 2010. Sales Tax payment is vendor responsibility. A 6% Florida sales tax and a 1% County tax totaling 7%, will be due on your total sales. No adult or offensive materials permitted. Handmade crafts and commercial booths accepted. No yard sale items. The WCA has the right to turn down any vendor selling items that conflict with the Association's country store.

No alcohol or drugs on premises.

Each participant is responsible for their own booth setup and disposal of their trash. Vendors may set up on Thursday from 2:00 – 6:00pm, and on Friday from 6:00am until 9:00am. All vehicles must be out of vending area by 9:00am and in their parking spaces. There will be security on Friday night. Any necessary setup on Saturday must be accomplished by 7:00am. No vendors are allowed to set up after 7:00 am Sat. morning, unless items are carried in vendor area by hand. No refunds given for booth fee. Wellborn Community Association will not be responsible for any injury, theft, losses or accidents during festival.

The entry form must be completed and submitted with payment before the dead line. [A self-addressed stamped envelope must be sent if advanced confirmation is wanted, or an e-mail address is needed.](#)
